Report on the Recommendations of Centre for Industry and Knowledge Partnerships (Appendix – II)

The 2nd Meeting of the Sectoral Committee of Centre of Industry and Knowledge Partnerships was held on 27th April, 2017 to discuss on approval of introduction of A one-year diploma programme to train students for a career in Interior Design to enable them to assist Interior Designers and Architects or work independently as Commercial interior designers, Residential interior designers, Institutional interior designers, Exhibition designers, Furniture designers, Design consultants or Freelancer designers

The committee discussed and deliberated about the duration of the Diploma. The content was found to be too much for a 1-year Diploma and it was suggested to consider the possibility of a 2 year or 3 year Diploma. It was also suggested to check with the regulatory body AICTE for scope of upward mobility post completion of such a diploma.

The recommendations of the Board of Studies of Department of Commerce and Management held on 24th March 2017 on the following were presented to members. It was informed to the members that 6 semester program structure and syllabus & curriculum of two semesters of 1st year were presented and obtained approval of BOS.
